
My focus is to secure immediate medical and financial support for clients to enable their rehabilitation. I also represent the families of those killed in accidents at

Recent notable cases include:

- Acting for **victims of terrorist attack at Finsbury Park** and Westminster Bridge.
- Acting for the family of respected scientist Maria Bitner Glindzicz at the **inquest into her tragic death** and subsequent civil claim
- Multi-million pound settlement against a car manufacturer for an employee who suffered severe brain injury falling off a ladder.
- Seven-figure settlement for a **guard assaulted at a Youth Offenders Institute**, causing severe head injury.
- Six-figure settlement for a Romanian national working and living in the UK involved in a serious road traffic accident.
- Significant six-figure settlement for an **aspiring boxer who suffered extreme anaphylactic shock** after being served a milk shake containing nuts.
- £1m recovered for an academic who suffered chronic pain following a road traffic accident, preventing him from working (previous solicitors put it through the small claims portal for low value personal injury claims).

I speak at training sessions for lawyers and regularly comment in the national press on high-profile cases with wide public interest, including BBC Radio 4 Today programme, BBC London Radio and BBC London News. I recently chaired a conference on the developing area of immunotherapy treatment for cancer patients.
